ORDER TO ADJUST DEADLINES IN SECOND AMENDED STIPULATED CASE MANAGEMENT ORDER

Irving H. Picard, as trustee ("Trustee") for the substantively consolidated liquidation of Bernard L. Madoff Investment Securities LLC ("BLMIS") under the Securities Investor Protection Act, 15 U.S.C. § 78aaa-lll ("SIPA"), and the chapter 7 estate of Bernard L. Madoff, and Legacy Capital Ltd. ("Legacy") filed a status report via letter on June 24, 2024 (the "Letter") [ECF No. 325] requesting adjustments to the current discovery schedule as set forth in the Order Further Amending Second Amended Stipulated Case Management Order [ECF No. 289]. This Court has considered the Letter, heard from the parties during the status conference on June 26,

2024, and found good cause for the requested adjustments to the discovery schedule.

NOW THEREFORE, it is ORDERED that:

1. Fact discovery shall be extended from July 1, 2024, to July 31, 2024;

2. The date by which to complete disclosures required by Federal Rule 26(a)(2) for any

expert testimony that a party intends to offer shall be extended from September 23,

2024, to October 23, 2024;

3. The date by which to complete all disclosures of opposition expert testimony or make

all applications for permission of the Court for testimony (i) by an expert that has not

been disclosed in accordance with the Federal Rules of Civil Procedure, and (ii) on

any issue that is beyond the scope of the opinion covered by the disclosures shall be

extended from December 2, 2024, to January 16, 2025;

4. The date by which to complete all expert discovery, including all expert depositions,

shall remain March 31, 2025; and

5. The parties also reserve the right to seek additional extensions or scheduling

adjustments based upon a showing of good cause.
