**EIGHTH APPLICATION OF BOWMAN AND BROOKE LLP AS SPECIAL COUNSEL
TO THE TRUSTEE FOR ALLOWANCE OF INTERIM COMPENSATION FOR
SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES INCURRED
FROM DECEMBER 1, 2023 THROUGH MARCH 31, 2024 AND FOR RELEASE OF
A PORTION OF FEES HELD BACK**

Bowman and Brooke LLP (the “Bowman”), special counsel for Irving H. Picard (the “Trustee”), trustee for the liquidation of the business of Bernard L. Madoff Investment Securities LLC (“BLMIS”) under the Securities Investor Protection Act of 1970, 15 U.S.C. §§ 78aaa *et seq.* (“SIPA”), and Bernard L. Madoff, submits this Application for interim compensation of legal fees in the amount of \$12,587.00 (of which 20% is to be deferred until the conclusion of the liquidation period), reimbursement of actual and necessary expenses in the amount of \$235.50 for the period from December 1, 2023 through March 31, 2024 (the “Compensation Period”), and the release of \$9,819.99 (which represents a portion of fees held back). In support of the Application, Bowman respectfully submits as follows:

I. BACKGROUND

1. On December 15, 2008, Judge Stanton of the United States District Court for the Southern District of New York, upon application filed on the same date by the Securities Investor Protection Corporation (“SIPC”), entered an order calling for the liquidation of BLMIS in accordance with SIPA and appointing the Trustee as BLMIS’s trustee.

2. BLMIS’s liquidation proceeding was removed to this Court pursuant to SIPA § 78eee(b)(4), and, pursuant to SIPA § 78fff(b), is being conducted as though it were a case under chapters 1, 3, and 5 and subchapters I and II of chapter 7 of title 11 of the United States Code.

3. Beginning on October 8, 2021, Bowman has served as special counsel for the Trustee.

4. On October 8, 2021, this Court entered an order approving the Trustee’s motion for authority to retain Bowman as special counsel.

5. The Trustee’s motion to retain Bowman established a fee arrangement pursuant to which Bowman agreed to a fee reduction in the amount of 10% as well as an additional holdback of fees in the amount of 20%.

II. SERVICES RENDERED BY BOWMAN

6. The legal services performed by Bowman on behalf of the Trustee during the time period covered by this Application are as follows:

7. Bowman advised the Trustee on issues arising under Arizona law.

III. COMPENSATION REQUESTED

8. The Application demonstrates how Bowman has both added value to BLMIS’s estate and advanced BLMIS’s liquidation proceeding.

9. Bowman has been mindful of the need to avoid undue legal fees in this case and has taken all reasonable steps to provide cost-effective representation while rendering services with the highest degree of skill and professionalism. To that end, Bowman has staffed this matter leanly and endeavored to eliminate duplication of effort by giving primary responsibility of the case to one partner.

10. From December 1, 2023 through March 31, 2024, Bowman provided a total of 32.00 hours of legal services to the Trustee in this case. Prior to the 10% discount, the total amount of fees incurred in this time period was \$13,985.56 and the total blended rate for professional services was \$437.05/hour. After the 10% discount, the total amount of fees incurred is \$12,587.00 and the total blended rate is \$393.34/hour. Bowman has agreed to a further 20% holdback of fees in the amount of \$2,517.40 resulting in the present request for compensation in the amount of \$10,069.60.

11. A breakdown of the total number of hours performed by each Bowman timekeeper is provided in **Exhibit A** attached hereto.

12. Bowman seeks reimbursement for out-of-pocket expenses incurred in connection with its representation of the Trustee during the Compensation Period in the amount of \$235.50. An itemized list of these expenses is detailed in **Exhibit B** attached hereto.

IV. RELEASE OF THE HOLDBACK

13. The Trustee's motion to retain Bowman established a Holdback fee arrangement in which 20% of the approved compensation is deferred until further order of the Court.

14. For the prior and current compensation periods, the amount of the Holdback for Bowman's fees is \$19,639.98. Bowman seeks a release of the Holdback in the amount of \$9,819.99 upon the support of SIPC.

15. SIPC has advised Bowman that it will file a recommendation in support of the fees and expenses in this Application and the release of the Holdback in the amount of \$9,819.99 for Bowman.

16. Hence, Bowman respectfully requests that this Court authorize the release of the Holdback payment to Bowman in the amount of \$9,819.99, as supported by SIPC.

V. GENERAL MATTERS

17. All of the professional services for which compensation is requested herein were performed by Bowman for and on behalf of the Trustee, and not on behalf of any other person or entity.

18. No agreement or understanding exists between Bowman and any other person for sharing compensation received in connection with this case, nor has any other person or entity agreed to provide Bowman with compensation for the legal services described herein.

19. SIPA § 78eee(b)(5)(A) provides in pertinent part that, upon appropriate application and after a hearing, “[t]he court shall grant reasonable compensation for services rendered and reimbursement for proper costs and expenses incurred . . . by a trustee, and by the attorney for such a trustee.” SIPA § 78eee(b)(5)(C) specifically establishes SIPC’s role in connection with applications for compensation and the consideration the Court should give to SIPC’s recommendation concerning fees, providing as follows:

In any case in which such allowances are to be paid by SIPC without reasonable expectation of recoupment thereof as provided in this chapter and there is no difference between the amounts requested and the amounts recommended by SIPC, the court shall award the amounts recommended by SIPC. In determining the amount of allowances in all other cases, the court shall give due consideration to the nature, extent, and value of the services rendered, and shall place considerable reliance on the recommendation of SIPC. SIPA § 78eee(b)(5)(C).

20. To the extent the general estate is insufficient to pay such allowances as an expense of administration, SIPA § 78eee(b)(5)(E) requires SIPC to advance the funds necessary to pay the compensation of Bowman. *See* also SIPA § 78fff-3(b)(2).

21. At this time, the Trustee has determined that he has no reasonable expectation that the general estate will be sufficient to make a distribution to general creditors or pay administrative expenses. SIPC has advised the Trustee that it concurs with this determination. Accordingly, any fees and expenses allowed by this Court will be paid from advances by SIPC without any reasonable expectation by SIPC of recoupment thereof.

22. Therefore, with respect to this Application, Bowman requests that, consistent with SIPA § 78eee(b)(5)(C), the Court “shall award the amounts recommended by SIPC.” *See McGraw v. Betz (In re Bell & Beckwith)*, 112 B.R. 876 (Bankr. N.D. Ohio 1990). Bowman expects that SIPC’s recommendation in support of the relief sought by this Application will be filed with this Court separately.

WHEREFORE, Bowman respectfully requests that this Court enter an Order:

- a. Granting this Application; and
- b. Allowing and awarding \$12,587.00, of which \$10,069.60 is to be paid currently and \$2,517.40 is to be held back through the conclusion of the liquidation period or until further order of the Court, as an interim payment for professional services rendered by Bowman to the Trustee from December 1, 2023 through March 31, 2024; and
- c. Allowing payment to Bowman in the amount of \$235.50 for reimbursement of expenses incurred by Bowman from December 1, 2023 through March 31, 2024; and

- d. Releasing \$9,819.99 to Bowman from the Holdback for prior and current compensation periods; and
- e. Granting Bowman such other and further relief as this Court deems just and proper.
