APPLICATION OF TAN KOK QUAN PARTNERSHIP AS SPECIAL COUNSEL TO THE TRUSTEE FOR ALLOWANCE OF INTERIM COMPENSATION FOR SERVICES RENDERED AND REIMBURSEMENT OF ACTUAL AND NECESSARY EXPENSES_INCURRED FROM APRIL 1, 2024 THROUGH JULY 31, 2024

Tan Kok Quan Partnership ("TKQP"), special counsel for Irving H. Picard (the "Trustee"), trustee for the liquidation of the business of Bernard L. Madoff Investment Securities LLC ("BLMIS" or "Debtor") under the Securities Investor Protection Act of 1970, 15 U.S.C. §§ 78aaa *et seq.* ("SIPA"), and Bernard L. Madoff, submits this Application for interim compensation of legal fees in the amount of \$36,127.05 (of which 20% is to be deferred until the conclusion of the liquidation period) and reimbursement of expenses in the amount of \$2,650.42 for the period from April 1, 2024 through July 31, 2024 (the "Compensation Period"). In support of the Application, TKQP respectfully submits as follows:

I. BACKGROUND

- 1. On December 15, 2008, Judge Stanton of the United States District Court for the Southern District of New York, upon application filed on the same date by the Securities Investor Protection Corporation ("SIPC"), entered an order calling for the liquidation of BLMIS in accordance with SIPA and appointing the Trustee as BLMIS's trustee.
- 2. BLMIS's liquidation proceeding was removed to this Court pursuant to SIPA § 78eee(b)(4), and, pursuant to SIPA § 78fff(b), is being conducted as though it were a case under chapters 1, 3, and 5 and subchapters I and II of chapter 7 of title 11 of the United States Code.
- 3. On January 30, 2023, this Court entered an order approving the Trustee's motion to retain TKQP as special counsel to the Trustee in all matters pertaining to Singapore law *nunc pro tunc* to January 13, 2023.
- 4. The Trustee's motion to retain TKQP established a fee arrangement pursuant to which TKQP agreed to a fee reduction in the amount of 10% as well as an additional holdback of fees in the amount of 20% ("Holdback").

II. SERVICES RENDERED BY TKQP

- 5. The legal services performed by TKQP on behalf of the Trustee during the time period covered by this Application are as follows:
- 6. TKQP advised the Trustee regarding various issues under Singapore and assist the Trustee with litigation where Singaporean law is implicated.

III. COMPENSATION REQUESTED

- 7. The Application demonstrates how TKQP has both added value to BLMIS's estate and advanced BLMIS's liquidation proceeding.
- 8. TKQP has been mindful of the need to avoid undue legal fees in this case and has taken all reasonable steps to provide cost-effective representation while rendering services with

the highest degree of skill and professionalism. To that end, TKQP endeavored to eliminate duplication of efforts by giving responsibility for the day-to-day conduct of the case to two attorneys and involving other attorneys only when necessary.

- 9. From April 1, 2024 through July 31, 2024, TKQP provided a total of 93.20 hours of legal services to the Trustee in this case. Prior to the 10% discount, the total amount of fees incurred in this time period was \$40,141.16 and the total blended rate for professional services was \$430.70/hour. After the 10% discount, the total amount of fees incurred is \$36,127.05 and the total blended rate is \$387.63/hour. TKQP has agreed to a further holdback of 20% of its fees in the amount of \$7,225.41 resulting in the present request for compensation in the amount of \$28,901.64.
- 10. A breakdown of the total number of hours performed by each TKQP timekeeper is provided in **Exhibit A** attached hereto.
- 11. TKQP seeks reimbursement of out-of-pocket expenses incurred in connection with its representation of the Trustee during the past Compensation Periods in the amount of \$2,650.42. An itemized list of these expenses is detailed on **Exhibit B** attached hereto.

IV.GENERAL MATTERS

- 12. All of the professional services for which compensation is requested herein were performed by TKQP for and on behalf of the Trustee, and not on behalf of any other person or entity.
- 13. No agreement or understanding exists between TKQP and any other person for sharing compensation received in connection with this case, nor has any other person or entity agreed to provide TKQP with compensation for the legal services described herein.
- 14. SIPA § 78eee(b)(5)(A) provides in pertinent part that, upon appropriate application and after a hearing, "[t]he court shall grant reasonable compensation for services

rendered and reimbursement for proper costs and expenses incurred . . . by a trustee, and by the attorney for such a trustee." SIPA § 78eee(b)(5)(C) specifically establishes SIPC's role in connection with applications for compensation and the consideration the Court should give to SIPC's recommendation concerning fees, providing as follows:

In any case in which such allowances are to be paid by SIPC without reasonable expectation of recoupment thereof as provided in this chapter and there is no difference between the amounts requested and the amounts recommended by SIPC, the court shall award the amounts recommended by SIPC. In determining the amount of allowances in all other cases, the court shall give due consideration to the nature, extent, and value of the services rendered, and shall place considerable reliance on the recommendation of SIPC.

SIPA § 78eee(b)(5)(C).

- 15. To the extent the general estate is insufficient to pay such allowances as an expense of administration, SIPA § 78eee(b)(5)(E) requires SIPC to advance the funds necessary to pay the compensation of TKQP. See SIPA § 78fff-3(b)(2).
- 16. At this time, the Trustee has determined that he has no reasonable expectation that the general estate will be sufficient to make a distribution to general creditors or pay administrative expenses. SIPC has advised the Trustee that it concurs with this determination. Accordingly, any fees and expenses allowed by this Court will be paid from advances by SIPC without any reasonable expectation by SIPC of recoupment thereof.
- 17. Therefore, with respect to this Application, TKQP requests that, consistent with SIPA § 78eee(b)(5)(C), the Court "shall award the amounts recommended by SIPC." *See McGraw v. Betz (In re Bell & Beckwith)*, 112 B.R. 876 (Bankr. N.D. Ohio 1990). TKQP expects that SIPC's recommendation in support of the relief sought by this Application will be filed with this Court separately.

WHEREFORE, TKQP respectfully requests that this Court enter an Order:

a. Granting this Application; and

b. Allowing and awarding \$36,127.05, of which \$28,901.64 is to be paid currently

and \$7,225.41, is to be held back through the conclusion of the liquidation period

or until further order of the Court, as an interim payment for professional services

rendered by TKQP to the Trustee from April 1, 2024 through July 31, 2024; and

c. Allowing payment to TKQP in the amount of \$2,650.42 for reimbursement of

expenses incurred by TKQP from April 1, 2024 through July 31, 2024; and

d. Granting TKQP such other and further relief as this Court deems just and proper.
